**Expired pre-licensing education course completion certificate:** 

Effective July 1, 2021, the department will no longer accept expired PLE course completion certificates. The department made an exception and allowed expired PLE course completion certificates to take their Ohio examinations due to the Ohio State of Emergency (COVID).

Persons who completed their pre-license education between September 17, 2019 and January 2, 2021, may use their expired pre-license education course completion certificate to take the appropriate state insurance exam up <u>until July 1, 2021</u>.

**Expired Driver's License:** 

<u>Until 7/1/2021</u>, PSI should accept expired driver's licenses that expired on or after March 9, 2020 thru April 1, 2021. However, after April 1, 2021, any driver's license that expires on or after April 2, 2021 are invalid and should not be accepted at the test site.

\*\*\*Candidates must bring a printed, original copy of the COURSE COMPLETION CERTIFICATE each time they are scheduled for an exam.
