Starting 5/1/25 the exam will be based on the 2021 edition for all ICC codes including the International Building Code, International Residential Code, International Mechanical Code, International Plumbing Code, International Fuel Gas Code, International Energy Conservation Code, International Swimming Pool and Spa Code.

Scope of Work: Glass and Glazing Contracting (Abbr: GLZ) the service that provides for the installation, assembly, repair, improvement, or removal of all makes and kinds of glass, glass work, mirrored glass, and glass substitute for glazing; executes the fabrication and glazing of frames, panels, sashes and doors; or installs these items in any structure. This specialty includes the installation of standard methods of weatherproofing, caulking, glazing, sealants, and adhesives. The RBC and CBC classifications and HIC and CIC specialties also provide for this function.
