Pre-demolition and Site Preparation	
Contact utility providers to discontinue service to the buildings to be demolished	
Obtain required permits from appropriate agencies (e.g., MDOT, State of Michigan) and schedule required inspections	
Notify regulatory agencies prior to start of building demolition projects (e.g., Department of Environmental Quality, MIOSHA, Environmental Protection Agency)	
Contact MISS DIG to locate and flag underground utilities	
Verify that utilities have been disconnected and capped at job sites	
Demolish or remove septic tank if present	
Take precautions to ensure that surrounding structures are not damaged during demolition	
Ensure that hazardous materials have been removed from structures before beginning building demolition

Follow MIOSHA regulations for maintaining a safe work environment	
Site Safety and Public Protection	
Set up barriers and traffic patterns to protect the public and workers	
Prevent injuries and exposure to harmful conditions or hazardous materials by using personal protective clothing and respiratory equipment	
Environmental Safety Concerns	
Control water runoff from sites during demolition	
Use required dust/silica reduction systems when operating power tools or equipment on concrete	
Dispose of contaminated materials generated at job sites in accordance with regulations (e.g., paints, fuels)
